

## **ORGANIC PLANT BASED EXPO**

### **Exhibitor Information**

The exhibitor will receive an invoice after booking which shall be paid within 8 days after reception. If it turns out that incorrect information has been given during booking, the exhibitor will receive a cancellation of the booking.

You will be contacted within a week regarding confirmation of booking and allocation of the exhibitor. DVF is entitled to move the allocation of exhibitors at any time.

If the exhibitor wishes to cancel the booking after payment, a fee corresponding to 10% of the price will be charged for cancellations done more than 4 months before the event (ie. before 05.07.22), 30% of the price for cancellation done between 3 and 4 months before event (06.07.22-05.08.22), 75% of the price for cancellation done between 2 and 3 months before the event (06.08.22-05.09.22), after 05.09.22 DVF will not be able to give a refund to the exhibitor.

If external circumstances of an unusual nature make it impossible to carry out the expo or only can be carried out under unreasonable circumstances, the participation fee will not be refunded. These can be labor disputes (strikes or lockouts), fire, including fire damage, war, terror, riots, disturbances, natural disasters and cloudbursts, currency restrictions, public seizure, import or export bans, public orders and restrictions, shortages of goods, disruption of ordinary traffic, including energy supply, significant price or tax increases and fluctuations, production or delivery difficulties due to conditions that can not be blamed on DVF.

The following exhibitors are accepted: vegan organic food, cosmetics, clothing, food service providers, retailers, cooks, dietitians, publishing houses, book authors, apps, education providers, associations, organizations, public authorities, and institutions (ask if not mentioned here).

We do not accept non vegan or non-organic products and political parties.

Joint stands have to be accepted by DVF before booking.

All marketing, products, and services must comply with applicable law.

DVF can not be held responsible for damages or losses during the expo. The exhibitor should make sure that their insurance covers such.

## **BEFORE THE EXPO**

### **Electricity, furniture, etc.**

The **deadline** for electricity, furniture, carpet and other equipment is on **13.10.2022**. After that Øksnehallen will charge an additional fee of 20%. Please note that these orders have to go directly to Øksnehallen at [dj@dgibyen.dk](mailto:dj@dgibyen.dk).

Please claim any damage on furniture etc. before the expo starts. Otherwise Øksnehallen cannot accept any claims.

## **SETUP**

The walls are white and hanging from the ceiling. You are NOT allowed to hang, pint, clue etc. on the walls.

Please claim any damage on walls before the show starts. Otherwise we cannot accept any claims.

Please stay within the booked square meters and do not use the aisles for goods.

We reserve the right to charge a fine of DKK 2,000 for failure to set up before the opening or dismantle a stand before closing.

### **Delivery by own vehicle**

Parking in the car park is restricted to vehicles weighing under 3,500 kg total weight or with a maximum height of 2m.
